2016 Annual Security Report

Each year JCCC, in compliance with the Jeanne Clery Crime Statistics Act (The Clery Act), compiles a report on the safety and security on campus. The report includes:

- Campus and community crime statistics
- Policy information
- Emergency preparedness programs and systems
- Safety tips
- Important phone numbers and contacts
- Overview of the College safety and security services

In addition, Campus Security Authority (CSA) training was provided to 160 employees as part of the annual training requirements. CSAs have mandatory reporting requirements for Clery-related crimes.

Lights, Cameras and More Cameras = Action

JCCC has invested in a state-of-the-art digital system to enhance safety and security on campus. As with the analog system, installations are concentrated in corridors, stairwells, building entrances and other public locations. Cameras are not installed in private offices or classrooms. This digital system is being phased onto campus through 2020. Highlights include:

- Original analog cameras installed 348
- New cameras installed to date 302
- Total cameras installed
by end of FY 2017-18..... 422
- Final count of cameras installed
at end of FY 2019-20..... 578*

*This number includes projected camera installations in two new and renovated campus buildings, ATB and WLB and includes buildings not previously covered, such as ATB, CLB, CSB, HSC, SCI, WLB and portions of the parking structures.

Emergency Preparedness has partnered with JCCC's Information Services and vendor partner, Sound Products, to complete an upgrade of JCCC's public address system. This upgrade is an all-in-one IP-based mass notification system over the campus network. It includes:

- Seamless interoperability with all communication mediums
- Constant reliability through endpoint supervision
- Clear and intelligible announcements through high-definition digital audio

Safety and Security Training

ALICE E-Learning: This tool is new and offers a simple way to refresh your ALICE training. ALICE training was incorporated as JCCC mandatory training in 2017-18.

Fall Professional Development Days:

Sessions offered included: Verbal Conflict Resolution, First Aid, CPR/AED, Weapons Policy Q&A, Emergency Preparedness 101, ALICE 1 and ALICE 2.

Group Training: ALICE 2 training was held with the Food Court and Java Jazz employees using workplace scenarios. Training was also provided at New Faculty Orientation, to adjuncts at a Saturday event, at the CAV kick-off and Public Safety Day event and with student ambassadors.

County-Wide Exercise: On Wednesday, Sept. 27, the Crisis Management Team was activated as part of a county-wide Emergency Operation Center exercise. JCCC's primary EOC was activated for four hours to practice responses to severe weather and power outages on and near campus. With a County Representative as the controller, 35 JCCC team members used emergency scenarios to formulate disaster and recovery plans.
