## New Course

Charles Foat was in attendance to represent the EMS curriculum updates. He explained that the new courses are expansions of previous courses (which are being deactivated), increasing the contact hours and competencies; EMS 129 replaces 128 and 132 replaces 131, and EMSs 133 is no longer needed. The course edits include title changes reflecting that the state has moved back to the term "paramedic." The program edits are a result of these changes, with differing credentials tied to each of the two new courses.



Concerns were raised that the new outlines for 129 and 132 do not have verbs, but they are in line with some other programs on campus that strictly follow national guidelines instead of campus outline policies; it was agreed that following the national guidelines to ensure that the courses were approved took precedence over the committee's desire to have verbs in the outline.

Matthew Schmeer moved to approve the new courses as a group with an edit to EMS 129, Ashley Rader seconded, and the motion carried.
