Upon completion of the program, students will be eligible to complete licensing exams. Successful completion of the exams will award a Kansas occupational license and the NREMT certification. The NREMT must be renewed every two years to remain active. NREMT is the basis of reciprocity; graduates must maintain their registry to gain credentials in other States. A limited number of States participate in the Recognition of EMS Personnel Licensure Interstate CompAct (REPLICA). Qualified EMS professionals licensed in a "Home State" are extended "Privilege To Practice" in Remote States for qualified circumstances. This may allow graduates with lapsed NREMT to gain licensure in other States without a current NREMT status.
